# √ Call to Order 6:00 pm

# √ Pool Project Review

- Comprehensive Summary Report
- Pool resurface within projected budget as outlined in January Minutes.
- · Post repair brushing went well and curing occurred according to 2 week timeline
- NWPM reported pool will need pump multiport valve (\$450)
- · A ladder broke and was repaired

#### √ Treasurer

- Distributed expenditures spreadsheet online/ several major payments will come out in June
- Report out on pool phone replacement with emergency cell phone/ Cox modem returned for realized savings of close to \$400 per year

## √ Lawn Maintenance

- Sprinkler Test and Adjust Bid
- \$12 per station
- 14X3 approximate = 42 Treasurer requested a list from vendor of what station inspection will include for approximate \$500 expenditure
- June Lawn Schedule Broad Leaf Grass Spray, planted one donated palm in pool area, two
  mowings with edging
- July plan to add dirt and sod to cover sprinkler wire line at May as much as will fit into lawn budget and clearing weeds from beds
- Shrub trimming- Ray said he could shape some of the shrubs at entrances. Call for some landscape volunteers
- Thank you to Ray for cutting up large downed limb that fell into May entrance
- Drainage trench in pool area need volunteers
